Mark's regulatory work includes development and implementation of public infrastructure projects, including drinking water and lead service line replacements, assisting clients prepare federal and other grants and funding requests and ensure ongoing compliance, assist with local, state and federal procurement, and provide advice on legislative planning, analysis, and drafting for business and industry groups.
