Many of Mike's clients are tax exempt organizations and he specializes in the tax regulation of lobbying and political activities as well as other tax-exempt legal matters.

Through his work, Mike has a comprehensive understanding of the regulation of alcoholic beverages under Wisconsin law. He is a member of the National Association of Alcoholic Beverage Licensing Attorneys and served on the 2018-2019 Wisconsin Legislative Study Committee on Alcohol Beverages Enforcement. He works with businesses in all three-tiers of the alcohol beverage industry – suppliers, wholesalers and retailers. He serves as counsel to both the Wisconsin Wine and Spirit Institute and the Wisconsin Beer Distributors Association.

Many of the matters Mike works on are controversial, high-profile and involve the courtroom of public opinion. He is skilled at explaining legal issues in compelling but accessible language and frequently interacts with the media.

Mike regularly speaks at events organized by businesses and trade associations and taught for over 10-years as an adjunct professor, "Political Law: Campaign Finance, Ethics & Elections" at the University of Wisconsin Law School. Mike is currently an adjunct faculty member at the University of San Francisco where he teaches a course on Political Law.
